If in the course of the first grade of the proceedings it is necessary to replicate to counterclaims and/or summon of possible third parties or intervene in other process, request protective measures and precautionary measures of any kind, give course to executive procedures, promote or resist or perform protective measures, urgent and precautionary or special, propose remedies or oppose it, or establish themselves in other processes or sub processes, litigation and not, between the same and/or more parts, and in the case there is the increase of the value of the case, the compensation referred to above should be integrated as a result of new quote with reference to said new procedural activity. Likewise must be estimated and agreed remuneration for the eventual additional phases of judgment. If the value of the deal is not determinable, it is generally considered the value between 26.000 and 260.000 according to the complexity of the case.

If the actual value of the deal is of particular importance for the object, for the number and complexity of the legal issues dealt with, for the relevance of the effects and results, even non-patrimonial, the fees must be agreed separately.

The following percentage increase is normally applied to the settlement of fees for disputes over € 520,000.00: for disputes ranging from € 520,000.00 to € 1,000,000.00 up to 30 percent more than the expected numerical parameters for disputes of value up to € 520,000.00; for disputes ranging from € 1,000,000,01 to € 2,000,000.00 up to 30 percent more than the numerical parameters envisaged for value disputes up to € 1,000,000.00; for disputes ranging from € 2,000,000.01 to € 4,000,000.00 up to 30 per cent more than the numeric parameters envisaged for value disputes up to € 2,000,000.00; for disputes from € 4,000,000.01 to € 8,000,000.00 up to 30 per cent more than the numeric parameters envisaged for value disputes up to € 4,000,000.00; for disputes with a value of over € 8,000,000.00 up to 30 percent more than the numerical parameters envisaged for the causes of value up to € 8,000,000.00; this last criterion can be used for any subsequent doubling of the value of the dispute.
